


How to Clearly Catalog the Work and Opportunities You Have Now to See Where You Need to Go

(No pressure, seriously! Need to gage where we are)


We need to look at income different ways

Not sure what kind of marketing you did?

- Get your numbers of:
 - Pitches sent
 - LOIs sent
 - Cold emails of other kinds sent (and source, LI, FB, Twitter, etc)
 - Conferences attended and deals discussed
 - How else are you getting clients?
- The dangers of over-tracking...at the time

What do these numbers tell us off the bat?

- Low, right? That's how we tend to feel until we get serious about numbers
- Where are the dips?
- What looks like it's not worth our time?
- Are there things that are low that you know also take up too much of your time?

What you need to know about your expenses for your taxes:

If it is something that is for work, WRITE. IT. OFF.
